Dear Mr. Bergman:

Please let this letter stand as a request by Lugano Diamonds for a waiver to the recently enacted Zoning in Progress that would prohibit any new restaurants from obtaining approval. Since the proposal is to have a room in the retail space that may occasionally have private dinner events, a "waiver" is necessary to proceed with the new location on Worth Avenue. Lugano Diamonds is not a restaurant as set for the below:

Lugano Diamonds is a luxury jewelry retailer – it does not sell food nor will they operate a restaurant/dining hall within the proposed space.

Lugano Diamonds may host some charity events at the proposed retail store on Worth Avenue that would include catering.

A few items are important to note on this subject:

- All in-salon events are catered and do NOT depend on any breakroom equipment for food-related services.
- o All in-salon events are private and invitation-only, no payment is required.
- o In-salon events are occasional and typically not on a weekly occurrence.


The proposal at 150 Worth Avenue is to include in the floorplan design elements that will allow flexible use – principally for retail use with occasional private, catered events (see attached Floorplan). Within the submitted plans, there is a table with seating for up to 16 people. This table is consistently and primarily used as a jewelry viewing surface, meeting space, and conference area. The induction range/oven will be used solely for warming food.


