STAFF RECOMMENDATION

Town staff recommends that Town Council Approve Resolution No. 096-2023, Approving the Award of a Purchase Order for Phase 4 Milling and Paving Improvements, Town of Palm Beach Undergrounding Program, to M&M Asphalt Maintenance, Inc. dba All County Paving in the Amount of \$499,822.00 and Establishing a Project Budget of \$625,000.00.

GENERAL INFORMATION

After the completion of each phase of undergrounding all roads are milled and resurfaced as part of the pavement management program.

Three bids were received in respond to Town Invitation To Bid No. 2023-45 for this project with time being of essence. The project was advertised in Town Website, Town E-Procurement Platform Bonfire and as well as in the Palm Beach Post.

Paving is scheduled to begin after the Labor Day Holiday contingent on all poles being down. Those streets to be paved as part of the Phase 4 North contract include List Road, Orange Grove Road, Monterey Road, Colonial Lane Queens Lane, El Pueblo Way, North Ocean Way from La Puerta Way to Queens Lane, North Lake Way from La Puerta Way to List Road and North Ocean Boulevard from La Puerta Way to List Road.

Staff recommends a waiver to Section 42-196 through Section 42-199 of the Town Code of

Ordinances to allow for extended work hours, days as necessary and approved by Public Works in case of weather or unforeseen event.

Staff also recommends a waiver to the Noise Ordinance for those same activities from Section 42-226 through Section 42-229 of the Town Code of Ordinances

FUNDING/FISCAL IMPACT

Funding for this program is from the Capital Improvement Program.
