Minutes of the Special Town Council Meeting Held on August 9, 2023

I. CALL TO ORDER AND ROLL CALL

The Special Closed Door Town Council Meeting was called to order on August 9, 2023, at 4:02 p.m. On roll call, all elected officials were found to be present, with Mayor Moore, participating virtually.

II. APPROVAL OF THE AGENDA

Council President Zeidman called for an approval of the agenda.
