STAFF RECOMMENDATION

Staff recommends the Town Council approve Resolution No. 138-2023, a non-competed proposal to the Government Finance Officers Association for Enterprise Resource Planning (ERP) Advisory Services in a not-to-exceed price of \$121,000 for consulting services.

SUMMARY EXPLANATION/BACKGROUND

The Town engaged Tyler Eden for an ERP solution in 2006 followed by implementation in 2007. Tyler Technologies has advised the Town our current ERP solution has a sunset date of March 1, 2027, and their goal is to have all clients migrated to a third party by the end of 2026.

ERP (enterprise resource planning) software is a business management system that integrates internal and external management information across an entire organization. It typically includes modules related to finance, human resources, procurement, inventory, and operations.

ERP systems are designed to enable organizations to optimize their processes, increase their awareness and connect them with customers, vendors, and partners. DCAA compliant ERP systems provide real-time insight into data enabling companies to make strategic decisions with accurate real time information.

The Government Finance Officers Association (GFOA) is a 501(c)3 non-profit association with 22,500 members representing nearly 10,000 local governments.
