RESOLUTION NO. 150-2023

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, DECLARING THE RESULTS OF THE TOWN CAUCUS; DIRECTING THE ACTING TOWN CLERK OF SAID TOWN TO PLACE THE NAMES OF CERTAIN CANDIDATES ON THE OFFICIAL BALLOT FOR THE GENERAL ELECTION TO BE HELD IN SAID TOWN ON THE NINETEENTH DAY OF MARCH, 2024; ADOPTING THE OFFICIAL BALLOT TO BE USED IN SAID ELECTION; AUTHORIZING THE ACTING TOWN CLERK TO ARRANGE FOR VOTING EQUIPMENT TO BE USED IN SAID ELECTION; AND DIRECTING THE MAYOR OF SAID TOWN TO ISSUE A PROCLAMATION OF SAID ELECTION, NAMING THEREIN THE CANDIDATES NOMINATED AND NAMED IN THE RESOLUTION; AND, DESIGNATING THE ACTING TOWN CLERK AND DEPUTY TOWN CLERK OF THE TOWN OF PALM BEACH AND THE SUPERVISOR OF ELECTIONS OF PALM BEACH COUNTY, OR DESIGNEES, TO SERVE AS THE CANVASSING BOARD.

WHEREAS, at a regular and duly called caucus of the Town of Palm Beach, Florida, held on December 5, 2023, the following persons were duly nominated at said caucus by the voters of the Town of Palm Beach for the offices of three Town Council persons of said Town of Palm Beach, Florida, with the term of office for Town Council persons Group One, Group Two, and Group Three, to be for two-year periods, terms ending in March 2026.

WHEREAS, the Acting Town Clerk has performed the necessary examination and certification required by Town Ordinance; and

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

SECTION ONE: It is hereby declared that the following candidates have been

nominated and qualified for election to the seats of Town Council Persons in Groups One, Two and Three, each for a two-year period:

SECTION TWO: it is hereby declared that Lewis "Lew" S.W. Crampton, having no opposition for election, is hereby declared to be elected as Town Council Person in Group One, effective as of the date of the general election, March 19, 2024.

SECTION THREE: it is hereby declared that Barbara "Bobbie" D. Lindsay, having no opposition for election, is hereby declared to be elected as Town Council Person in Group Two, effective as of the date of the general election, March 19, 2024.

SECTION FOUR: The Acting Town Clerk is hereby directed to have official ballots prepared for the said election and have printed the names of the persons nominated for Town Council Person in Group Three for a term of two years. Since the candidates for Town Council Group One and Group Two had no opposition, the official ballot to be used in said election is substantially as follows:

SECTION FIVE: The terms of the office of the elected officials referenced shall begin and shall run from the first regular meeting of the Town Council following the March 19, 2024, election.

SECTION SIX: There will be seven (7) precincts with three polling locations in said election, as follows:

Precinct 5605 – South Fire-Rescue Station, 2185 S. Ocean Blvd., Palm Beach, FL 33480

Precinct 5607 – South Fire-Rescue Station, 2185 S. Ocean Blvd., Palm Beach, FL 33480

Precinct 5608 – South Fire-Rescue Station, 2185 S. Ocean Blvd., Palm Beach, FL 33480

SECTION SEVEN: The Supervisor of Elections of Palm Beach County shall provide the Town with necessary vote processing equipment and election services for the purpose of conducting a Uniform Municipal Election during the 2024 calendar year and a Run-Off Election, if necessary. The Supervisor of Elections of Palm Beach County shall also provide selected clerks, deputies, and inspectors, who are hereby directed to hold said election in accordance with law and in such a manner as to prevent fraud, deceit, and abuse thereat, and to make their return of the result of said election to the Town Council in a manner prescribed by law.

The Town Council authorizes the Acting Town Clerk to assign replacement and/or On-Call Poll Workers as needed.

SECTION EIGHT: The Mayor of the Town of Palm Beach is hereby required to issue her Proclamation of said Election and the date: March 19, 2024, between 7:00 a.m. and 7:00 p.m. The names of the candidates proposed for office in said election shall be included in such Proclamation, which shall be printed in the Palm Beach Post on December 13, 2023, and in El Latino on December 15, 2023. The Acting Town Clerk shall also post a copy of said Proclamation on the bulletin board in Town Hall.

SECTION NINE: The Town of Palm Beach Acting Town Clerk or her designee, The Town of Palm Beach Deputy Town Clerk or designee, and the Palm Beach County Supervisor of Elections or designee are hereby designated as the Town of Palm Beach Canvassing Board to carry out the duties, as prescribed in the Florida Statutes, for absentee ballots, the testing of the tabulating equipment, and to supervise the canvassing of the returns of the elections, as prescribed by law.
