






A. HISTORIC FIRST FLOOR PLAN






A. HISTORIC SECOND FLOOR & TOWER PLAN








A. NORTH ELEVATION




C. SOUTH ELEVATION




B. WEST ELEVATION




D. EAST ELEVATION






A. NORTH COURTYARD ELEVATION

B. WEST COURTYARD ELEVATION




















