STAFF RECOMMENDATION

Staff recommends that the Town Council consider the request from Jeff Wildes, President of Wildes Builders regarding a time extension in which to complete the construction of a new two-story single-family residence at 225 Wells Rd. The request is to extend the permit by twenty-three months to complete work by June 30, 2026.

GENERAL INFORMATION

The current owner is LLPB Trust who purchased the property in May of 2023. The permit was issued July 29, 2022, with a total of twenty-four months for completion. Expiration date is July 29, 2024. The contractor explains in their letter dated July 12, 2024, the need for extension is due to the original owner and contractor who stopped the construction for over a year. There was a transition to a new owner and new contractor. In addition, plan revisions have delayed the project an additional ten months. The revised construction schedule shows the project completion to be June 30, 2026.

The applicant appears to have complied with all new requirements for neighbor notice.


