



PREFERRED WEST PERIMETER ELEVATION RENDERING
















PREFERRED YARD SECTION DIAGRAM E/W FACING SOUTH 1/8" = 1'- 0"









ALTERNATE YARD SECTION DIAGRAM E/W FACING SOUTH 1/8" = 1'- 0"









