Minutes of the Special Town Council Budget Workshop Held on September 11, 2024

I. [CALL TO ORDER AND ROLL CALL \(1:05\)](#)

The Special Town Council Budget Workshop was called to order on September 11, 2024, at 5:01 p.m. On roll call, all elected officials were found to be present.

II. [PLEDGE OF ALLEGIANCE \(1:24\)](#)

Council President Lindsay led the Pledge of Allegiance.

III. [APPROVAL OF AGENDA \(2:09\)](#)

A motion was made by Council Member Cooney and seconded by Council Member Araskog to approve the agenda. The motion was carried unanimously, 5-0.

IV. [COMMUNICATIONS FROM CITIZENS - 3 MINUTE LIMIT \(2:27\)](#)

No comments were heard at this time.

V. [PUBLIC HEARING ON PROPOSED MILLAGE RATE, TENTATIVE FY25 BUDGETS, AND NON-AD VALOREM ASSESSMENTS \(2:49\)](#)

A. Notice of Proposed Property Taxes

Council President Lindsay announced that pursuant to the Notice of Proposed Property Taxes, which the Palm Beach County Property Appraiser had mailed to each property owner, the Public Hearing had been announced to commence at 5:01 PM. She further stated that the discussion would include the Fiscal Year 2025 proposed millage rate and tentative General Fund, Debt Service Fund, and other funds budgets, including the approval of Resolution No. 100-2024 and Resolution No. 115-2024. President

Lindsay then announced that a public hearing would also be conducted to discuss non-ad valorem assessments for commercial solid waste collection, town beautification, and underground utility projects, including approving the associated Resolutions.

B. Proposed Operating Millage Rate

President Lindsay stated that the Fiscal Year 2025 General Fund proposed an operating millage rate of 2.6110 mills, representing a 10.6% increase over the rolled-back millage rate of 2.3608 mills.

C. Reasons for Proposed Operating Millage Rate Increase Over the Rolled-Back Millage Rate

Council President Lindsay stated that, as required by State Law, she would request the Town Manager to identify why the ad valorem taxes were being increased from the rolled-back rate.

Town Manager Kirk Blouin explained that the FY25 General Fund budget increased by \$14,367,618 or 13.71% from the FY24 budget. The increase is mostly the result of the transfer to the Capital Improvement Fund to fund the paving projects related to the Townwide Undergrounding plan, the North Canopy drainage, and other major capital projects. Also, a two-million-dollar transfer from the general fund assigned fund balance to the Equipment Replacement Fund will help fund the replacement of the Town's Financial, Procurement, and Human Resource software. In addition, commodity and other contractual services increased by over \$1.5 million due to inflationary causes. Salaries and benefit costs increased due to the seven (7) additional Public Safety positions that will be funded at the start of FY25, as well as merit and COLA increases for employees. Property tax revenue increased by \$7,614,990 to cover the increase in the Capital Improvement Fund transfer and the balance to cover salary, benefit, contractual, and commodity cost increases.

There were no comments or questions from the public at this time.

Town Manager Blouin read Resolution No. 100-2024 by title into the record.

Council President Lindsay stated that the Resolution would set the proposed millage rate of 2.6110 mills for the General (Operating) Fund.

A motion was made by Council Member Cooney and seconded by Council Member Moran to approve Resolution No. 100-2024. The motion was carried unanimously, 5-0.

Bob Miracle, Deputy Town Manager, stated that Town staff recommends approval of Resolution No. 101-2024, the final assessment rate resolution for the proposed maintenance assessment for the Peruvian Avenue 400 block streetscape project assessment area in Fiscal Year 2025, with a total assessment amount of \$29,630.

Town Manager Blouin read the Resolution by title.

A motion was made by Council Member Cooney and seconded by Council President Pro Tem Crampton to approve Resolution No. 101-2024. The motion was carried unanimously, 5-0.

Town Manager Blouin read the Resolution by title.

A motion was made by Council President Pro Tem Crampton and seconded by Council Member Moran to approve Resolution No. 102-2024. The motion was carried unanimously, 5-0.
