I am completing my first term on the SPB. We have accomplished a lot during my first term. I would like to continue to contribute. We live on a barrier island. Coastal Protection is a key element of our Comprehensive Plan. The protection of upland properties is an important concern for all residents, including those in South End condominiums. Communicating the efforts and successes of the Town's shore protection program to Town residents has been a key initiative of this SPB under the leadership of Melissa Ceriale and Warren Belmar. As a member of the Executive Committee of the Citizens Association (CAPB). I am in an excellent position to implement this strategy by facilitating SPB communication in the South End by means of seminars, newsletter articles and education. As an example, in April this year CAPB held a well attended seminar on South End shore protection headlined by Ms.Ceriale and Town Consultants.which led, among other things, directly to the re-engagement of the Sloan's Curve condominium complex with the Town's dune restoration efforts. A second such program headlined by Town Staff will lead off this year's slate of CAPB seminars on November 21. In addition, there are several long-term issues that may finally be in a position to be resolved during the next 3 years. Foremost among them is a real possibility of receiving EPA approval so that Reach 8 will be able to conduct near beach sand renourishment. I would like very much to be a part of that resolution.

SHORE PROTECTION BOARD

The Shore Protection Board acts in an advisory capacity and makes recommendations to the Town Council in matters relating to shore protection, coastal management, beach nourishment, coastal armoring, the sand transfer plant, and matters relating to the Town's Lake Worth lagoon shoreline. The scope of the Board shall include long term planning, budgeting, lobbying, public education, and intergovernmental coordination.Members of the Board shall possess knowledge of or interest in shore protection, coastal management,and/or beach nourishment. The Board shall be composed of seven members to be appointed by the Town Council. Members of the Board shall serve for terms of three years. Each member of the Board is required to be a resident of the Town of Palm Beach, except that one member of the Board may be a non-Town resident who possesses specific knowledge or skills directly related to shore protection, coastal management, and beach nourishment. The Board shall hold at least four meetings per year and more if deemed necessary.
