

RESOLUTION NO. 002-2025

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN
OF PALM BEACH, PALM BEACH COUNTY, FLORIDA,
APPROVING A REVISED INTERLOCAL AGREEMENT
WITH THE SCHOOL BOARD OF PALM BEACH COUNTY
AND EACH OF PARTICIPATING MUNICIPALITIES OF
PALM BEACH COUNTY TO FACILITATE
COORDINATION IN THE PLANNING OF PUBLIC
SCHOOLS**

WHEREAS, the Town of Palm Beach, Florida (Town) is a municipal corporation of the State of Florida with such power and authority as has been conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes (F.S.); and,

WHEREAS, Section 163.01, F.S. permits local governments to make the most efficient use of their powers by enabling them to cooperate with one another on a basis of mutual advantage by providing services and facilities that will be mutually beneficial to the local communities; and,

WHEREAS, pursuant to Section 163.01, F.S., the Town has previously entered into an Interlocal Agreement with The School Board of Palm Beach County and each of participating municipalities of Palm Beach County to facilitate the coordinated planning of public schools; and,

WHEREAS, the initial Interlocal Agreement between the municipalities, Palm Beach County and the School Board expired in 2011 and the School Board and Palm Beach County have proposed a new Interlocal Agreement with the School Board to facilitate coordination in the planning of public schools; and,

WHEREAS, the Town Manager recommends to the Town Council that the Town enter into a revised Interlocal Agreement with the School Board to facilitate coordination in the planning of public schools; and,

WHEREAS, the Town Council has determined that it is in the best interest of the Town to adopt the Interlocal Agreement.

NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL of the Town of Palm Beach, Palm Beach County, Florida, as follows:

Section 1. The whereas clauses are hereby incorporated herein and are true and correct.

Section 2. The Mayor is hereby directed and authorized to execute the Participation Agreement to the Interlocal Agreement, a copy of which is attached hereto as Exhibit "A" and made a part hereof.

Section 3. This Resolution shall take effect immediately upon its execution.
